Dear Reporter:

This letter provides clarification to the July 23, 2007, Dear Reporter letter concerning the Ute Indian Tribe's lockbox agreement with the Wells Fargo Bank. Enclosed is a list of the payors that reported Ute Indian Tribe lease revenues from January 2006 to August 2007. These instructions do not affect royalty payments for the Bureau of Indian Affairs (BIA) Uintah and Ouray Agency allotted Indian leases or payments to the Ute Distribution Corporation.

Instructions for payments to Ute Indian Tribe (a.k.a. Northern Ute Tribe) are outlined in the July 23, 2007 Dear Reporter letter. Payments to any other Indian Tribe; Southern Ute, Ute Mountain Ute, etc., or any BIA Indian allotted lease do NOT change. There are NO changes to the Blackfeet, Jicarilla Apache, Navajo Nation, Southern Ute Tribe lockbox instructions.

Please follow the July 23, 2007 instructions if you currently report and pay royalties for Ute Indian Tribe (Northern Ute Tribe) leases. If you do NOT report and pay royalties on Ute Indian Tribe leases no action is necessary.
