TO ALL 3160 OPERATORS

Dear Operator:

Effective as of the October 1992 production month, the Form MMS-3160, Monthly Report of Operations, due December 15, 1992, will have a new fatal edit requiring a four digit gas plant number when gas is transferred to a gas plant for processing prior to the royalty determination point. The gas plant name is still required after the number (see attachment no. 1). Attachment no. 2 provides a key to help you identify the gas plant number and name by using the State code, the gas plant name, the operator number/name, and the location.

A new Form MMS-3160 (see attachment no. 3) can be used, or you may continue to use the old Form MMS-3160. The new Form MMS-3160 reflects two changes: 1) the "Plant Number/Name" (as described above), and 2) the "Authorizing Name" which may be typed or printed is now required.
