## Notes

A product is either RIK or RIV. If a lease produces Oil and Gas, the Oil could be RIK and the Gas could be RIV, vice versa, or they could both be RIK.

ONRR prepares Form ONRR-2014s for the purchaser. In rare instances where an operator has transportation prior to a delivery point, either ONRR or the operator can submit the Form ONRR-2014 for TC 11 and 13 only.
