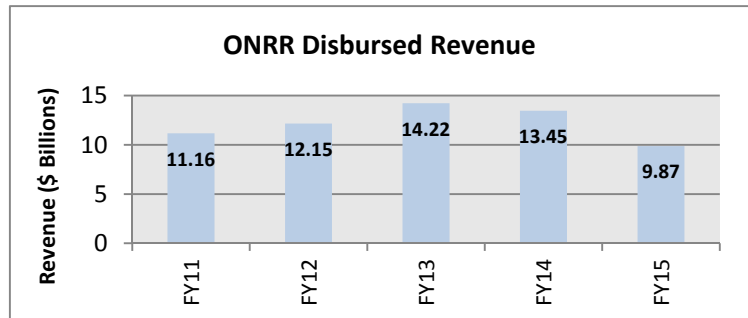

# Office of Natural Resources Revenue Highlights

The Office of Natural Resources Revenue (ONRR) is the office in the U.S. Department of the Interior that manages Federal and Indian mineral revenues and Federal offshore energy and mineral revenues. Through its programs, ONRR manages the collection, verification, and disbursement of revenues associated with the leasing and production of oil, natural gas, solid minerals, and renewable energy and minerals on Federal and Indian lands.

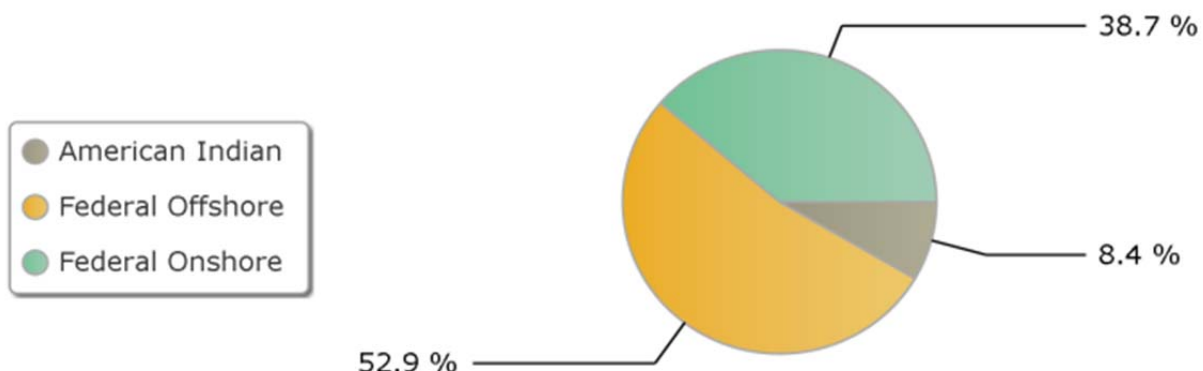


In Fiscal Year 2015, ONRR collected and disbursed **\$9.87 billion** from energy production on Federal and American Indian lands and the outer continental shelf. Substantially lower oil and gas prices contributed to the decline in disbursements from FY 2013 to FY 2015.

## Where Does the Revenue Come From?

ONRR collects royalties, rents, bonuses, and other revenues that mineral revenue reports that payors, or companies, submit to ONRR.

## ONRR is providing expertise to support the implementation of USEITI

The U.S. Extractive Industries Transparency Initiative (USEITI) is part of an international effort to promote open and accountable management of natural resources. Supporting USEITI implementation advances the revenue reform efforts under way in ONRR and benefits the American public, whose interests will be better protected by a strong commitment to oversight and transparency.

The first USEITI Annual Report was published in December 2015 and is the first ever fully online EITI report. It combines interactive data visualizations and detailed data sets to enhance user experiences and provides context about the government's role in the extractive industries.

### Indian Outreach

ONRR's outreach programs have responsibility for over 34,000 mineral owners throughout the United States and have routine contact with over 1,400 individual Indian mineral owners per month. In FY 2015, ONRR conducted 133 Indian outreach sessions for tribes and individual Indian mineral owners and responded to 14,160 Indian inquiries.

#### Diversity and Inclusion

By seeking out different points of views and perspectives, we strive to improve ideas, work products, and decisions.

### Ensuring Proper Revenue Collection

In FY 2015, ONRR collected an additional \$114.9 million in royalties, interest, and penalties because of ONRR's proactive compliance efforts, which included:

- 667 compliance reviews
- 110 audits
- 46,052 data mining exception resolutions
- 172 enforcement actions
