Dear Reporter:

On May 31, 1995, the Jicarilla Apache Tribe (Tribe) notified all producers and working interest owners on Jicarilla Tribal lands of the Tribe's decision to take all gas royalty in-value beginning July 1, 1995.

Effective with July 1995 production, reporting procedures and related information for the leases affected by this change are:

- 1. Report in-value transactions on the Report of Sales and Royalty Remittance (Form MMS-2014) using Transaction Code 01. The first report is due by the end of August 1995 for July production. In-value reporting instructions are available in the Minerals Management Service (MMS) Oil and Gas Paver Handbook, Volume II (Handbook), Section 3.3.2, Royalties Due on Federal and Indian Leases, Transaction Code 01.
- 2. Make payments to the Tribe's Lockbox address using Payment Method 07 on Form MMS-2014. Questions regarding Lockbox payments should be directed to the Royalty Accounting Division of MMS. The Lockbox address is:

- 3. Report advance rental payments due on or after July 1, 1995, on Form MMS-2014 in accordance with Section 3 of the Handbook and paid to the Tribe's Lockbox address. Refunds and recoupment of rental payment made after July 1, 1995, should be made in accordance with the provisions in Section 3.1.4 of the Handbook.
- 4. Request refunds of lease rentals paid to the Tribe while the leases were in a Royalty-In-Kind (RIK) status from the Tribe at the following address:

5. Do not adjust any RIK lines previously reported to MMS. The MMS is reconciling the Tribe's RIK contract and will contact lease operators and payors to resolve any discrepancies.

6. Base valuation on applicable lease terms, laws, and regulations, including dual accounting and major portion analysis.

The MMS established in-value selling arrangements effective July 1, 1995, for the reporters that reported Jicarilla Tribal RIK production prior to December 1994. Payor Confirmation Reports are enclosed, if applicable. If you report on the Model Form MMS-2014, these selling arrangements will appear on your July Model.

If you were not previously established as a payor, but will be reporting and paying royalty in-value, please submit Payor Information Forms by August 1, 1995, for the appropriate leases.
